June 1, 2024 – August 31, 2024

THE PRIZES: One Grand Prize Winner will win a 2024 Toyota BZ4X valued at approximately Forty Three Thousand Seventy Dollars and No Cents (\$43,070.00), or alternatively, at their option, \$15,000 cash (see below), and Thirteen (13) weekly finalists and One (1) “final day finalist” (each a “Finalist”) will each receive \$1,000 gift cards to Carnival Cruise Lines. **NO PURCHASE IS NECESSARY TO REGISTER, ENTER, OR WIN.**

SPONSOR: The Giveaway is created and sponsored by LifeStream Blood Bank (“LifeStream”), a California Non-Profit Public Benefit Corporation, and tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code (“IRC”), 384 W. Orange Show Road, San Bernardino, California 92408.

DATES: The “Crusin Into Summer” 2024 Toyota BZ4X Giveaway (“The Giveaway”) begins on June 1, 2024 at 9:00 am PDT and ends at 2:00 pm PDT on August 31, 2024 (the “Giveaway Period”). Entries received before or after The Giveaway Period are not eligible to win. The Giveaway Period shall be comprised of 14 separate “Entry Periods,” 13 of which comprise a calendar week within The Giveaway Period, with each such Entry Period commencing on a Saturday at 9:00 am Pacific Daylight Time and ending on the following Friday at 5:00 p.m., Pacific Daylight Time (each such Entry Period being June 1 to June 7 2024, June 8 to June 14, 2024, June 15 to June 21, 2024, June 22 to June 28, 2024, June 29 to July 5 2024, July 6 to July 12 2024, July 13 to July 19 2024, July 20 to July 26, 2024, July 27 to Aug 2 2024, Aug 3 to Aug 9 2024, Aug 10 to Aug 16 2024, Aug 17 to Aug 23 2024 and Aug 24 to Aug 30, 2024). The final Entry Period is on August 31, 2024 from 10:00 am to 2:00 pm, Pacific Daylight Time, and shall comprise only of entries actually received in person at Toyota of San Bernardino, 650 Auto Center Drive W, San Bernardino, CA 92408 on such date and during such time. Entries received during an Entry Period are only eligible to win the prize for that Entry Period, and any Entries received before or after each Entry Period are not eligible to win the prize for that Entry Period. Each Entry Period Winner will also automatically be entered into the drawing for the Grand Prize. LifeStream is not responsible for any lost, late, illegible, incomplete, damaged, mutilated, misdirected, misdelivered, or delayed Entries, or for technical or human errors or failures of any kind in connection with the submission, transmission or processing of Entries, including without limitation, any malfunctions or failures of computer hardware, computer software, networks or telephone equipment, or any technical problems or traffic congestion on the Internet or at any website or any combination thereof.

ELIGIBILITY: The Giveaway is open to legal residents of the United States, who are at least 18 years of age on JUNE 1, 2024, who either (a) present to give blood at any LifeStream donor center or mobile drive during The Giveaway Period or (b) who go to any LifeStream donor center during The Giveaway Period and properly complete an entry form. No online or mail in entries will be accepted. A list of the LifeStream donor centers accepting entries is at the end of these Rules.

Current or former (within the immediately preceding 12 months) employees, agents or officers of LifeStream, Thirty Second Street Media, Toyota of San Bernardino and Carnival Cruise Lines, or any entity involved in the development, production, implementation and distribution of The Giveaway, including any advertising or Giveaway agency, supplier of prizes for The Giveaway, parent company, service provider, subsidiary or affiliate of any such entity or any other entity directly associated with The Giveaway or any member of the immediate family of (i.e., spouses, domestic partners, siblings, parents, children, grandparents, grandchildren and other persons residing in the same household (related or not) of any of the foregoing individuals), are ineligible to enter The Giveaway. Eligibility is contingent upon agreement to, compliance with, and fulfillment of all requirements of these Rules. LifeStream may, in its sole discretion, disqualify any Entrant it finds to be in violation of these Rules. LifeStream, in its discretion, may require persons who register for or enter The Giveaway to provide verification of eligibility.

The drawing is void where prohibited. Residents of jurisdictions where this Giveaway is not permitted, or where LifeStream would be required to register or be restricted in any other way, are not eligible to enter or to win a prize.

HOW TO ENTER: Persons meeting the above qualifications presenting at a LifeStream donor center or mobile drive location from 9:00 am California time on June 1, 2024 – 5:00 pm California time on August 30, 2024, or physically present themselves at Toyota of San

Bernardino from 10:00 am -2:00 pm California time on August 31, 2024, are eligible to enter the drawing. Entries may also be made, in person, at any of the LifeStream donor centers accepting walk-in entries listed at the end of these Rules, during such center's normal operating hours. No entries will be accepted at any other location or after the expiration of The Giveaway Period.

DONOR ENTRY: Persons intending to donate blood must complete a donor eligibility interview during The Giveaway Period to enter The Giveaway. Persons who have completed the donor eligibility interview will then also, at that, time, have the opportunity and right to disclaim and opt out of participating in The Giveaway by filling out a form to that effect, at which time such Person will not be eligible to receive any Prize and will not be deemed a Entrant. It is the responsibility of the person intending to donate to ensure LifeStream has the correct contact phone number, email address (if they have one) and such other contact information as may be reasonably requested, so that they may be contacted in the event their name is drawn as a Finalist.

NON-DONOR ENTRY: NO PURCHASE OR BLOOD OR PLATELET DONATION is required to enter The Giveaway or to win a prize. Persons not intending to donate blood (non-donors) may fill out an entry form in person at one of LifeStream donor centers (but not mobile drive locations) listed at the end of these Rules prior to the expiration of The Giveaway Period or at Toyota of San Bernardino on August 31, 2024 from 10:00 am-2:00 pm. **No online or mail in entries will be accepted.**

Entries from donors or non-donors will only be accepted during Livestream's normal operating hours at the applicable participating LifeStream donor center (but not at any mobile drive) during The Giveaway Period. **ONLY ONE ENTRY PER PERSON IS ALLOWED PER ENTRY PERIOD.**

MULTIPLE ENTRIES: All Entrants, donors and non-donors, may not submit more than one Entry per Entry Period. **HOWEVER**, all Entrants, donors and non-donors, **ARE PERMITTED TO SUBMIT ONE ENTRY DURING EACH ENTRY PERIOD; PROVIDED** , **HOWEVER**, that no more than 1 entry (combined as a donor and non-donor) may be submitted by any individual in any one Entry Period, Entrants who submit more than one entry per Entry Period are not eligible to win any prize.

GRAND PRIZE: The Grand Prize is a 2024 Toyota BZ4X VIN# JTMAAAAA1RA042778 valued at approximately Forty Three Thousand Seventy Dollars and No Cents (\$43,070.00), the actual vehicle being chosen by Toyota of San Bernardino, which may have a sticker price in excess, but not less than, \$43,070.00 **OR** a one-time lump sum cash payment of \$15,000, such cash prize being given by Toyota of San Bernardino, at the Grand Prize Winner's election,. Only one Grand Prize will be awarded.

The 2024 Toyota BZ4X will be awarded through LifeStream's agreement with Toyota of San Bernardino. The cash prize, if chosen, will be paid by bank or cashier's check to the Grand Prize Winner. The Grand Prize Winner must make the prize selection in writing between the 2024 Toyota BZ4X and the lump sum cash payment no later than August 31, 2024 at 5:00 pm Pacific Time. If no selection is made by the winner by that deadline, the Grand Prize will become the cash alternative. The Grand Prize (whether the vehicle or the cash payment) does not include

sales or income taxes; license, title, and registration fees; delivery or transportation costs; or any other costs associated with the winning and use of the Grand Prize. The Grand Prize is nontransferable and non-refundable and must be accepted as awarded in “as-is, where-is, with all faults” condition. Except as expressly stated in these Official Rules, LifeStream makes no representation or warranty of any kind or character, expressed or implied, concerning the Grand Prize. NO EXPRESS WARRANTIES ARE GIVEN AND NO AFFIRMATION OF LIFESTREAM BY WORDS AND/OR ACTIONS WILL CONSTITUTE A WARRANTY.**

If the Grand Prize Winner chooses the 2024 Toyota BZ4X , they will be solely responsible for all applicable state, federal and local sales and income taxes and any other taxes associated with the winning and use of the Grand Prize; all license, title, and registration fees; all delivery or transportation costs; and any other costs associated with the winning and use of the Grand Prize, as well as insurance (proof of which must be shown prior to delivery) and pickup or delivery costs at the dealership, as well as any non- standard features, option or upgrades chosen by the Grand Prize Winner and negotiated with the dealership. In the event that the Internal Revenue Service (“IRS”) or any state tax authority, requires LifeStream to collect income taxes upon delivery of the Grand Prize to the Grand Prize Winner, and if the Grand Prize Winner receives or elects to receive the lump sum cash amount then required taxes will be withheld from the lump sum cash amount to be distributed, and if the Grand Prize Winner elects to receive the 2024 Toyota BZ4X, the Grand Prize Winner is responsible for paying LifeStream the estimated federal and state withholding tax amount before delivery can occur, which tax withholding amount will be submitted by LifeStream to the IRS on the Grand Prize Winner’s behalf. Federal and state withholding laws are subject to change without notice. The withholding laws in effect at the time the Grand Prize is claimed will be followed.

The Grand Prize Winner will have until September 30, 2024 (30 days after the drawing) to pay all required taxes to LifeStream, take delivery of the Grand Prize, and meet all other requirements of these Official Rules. If the Grand Prize is not redeemed by that date, or if the Grand Prize Winner does not otherwise meet all requirements of these Official Rules by that date, then the Grand Prize is automatically forfeited and LifeStream will select a new Grand Prize Winner at random from all remaining eligible Finalists as set forth below.

If the Grand Prize Winner choses the cash prize of \$15,000, the 2024 Toyota BZ4X shall not be awarded to any person, and vis-versa. The winner of the Grand Prize shall also be able to keep his/hers/their Finalist Prize of the \$1,000 gift card to Carnival Cruise Lines.

FINALIST PRIZES: 14 gift cards, each valued at One Thousand Dollars (\$1,000.00) to Carnival Cruise Lines, will be awarded, one to each of the fourteen (14) Finalists. The gift cards may be used towards the purchase of a Carnival cruise and can be redeemed onboard toward the “Sail & Sign” account for gifts, drinks, and fun, on board a Carnival cruise. All taxes are the responsibility of the winners. The gift card prizes are subject to the terms and conditions delivered with, or printed on, said cards, and as otherwise determined by Carnival Cruise Lines

for which said card applies, which may include applicable travel dates, age restrictions, and expiration dates. Each Finalist agrees that the gift cards are transferred to said Finalist “As-Is and with All Faults” and LifeStream accepts no liability or responsibility regarding the use thereof. Each Finalist agrees that if any issues arise with the usage of the gift cards, they will look solely to Carnival Cruise Lines for resolution thereof. Additionally, LifeStream shall not be liable for any lost or damaged gift card after it has been given to the Finalist, nor shall LifeStream have any obligation to replace any lost or damaged gift card.

TAXES AND FEES: Each winner of the Grand Prize and a Finalist Prize shall be responsible for all income taxes and any other applicable taxes on said Prize. An IRS form 1099 will be issued, if required by law. The Giveaway prizes consist only of the prizes expressly specified herein. Each winner is subject to and shall abide by the income reporting and, if applicable, the payment of any taxes due, per the laws, rules and regulations of the winner’s country, state, county and city of residence. LifeStream makes no guarantee that the IRS will accept the value of cash or other prizes for the purpose of determining any income tax that may be due from winners. LifeStream takes no responsibility for prize winners' tax liabilities. Each Entrant is to consult their own tax advisor. Any costs or expenses associated with the acceptance or use of any prize are the responsibility of the recipient. SELECTION OF FINALISTS: Only the Finalists, whose names will be drawn from the eligible entries received during The Giveaway Period, will be eligible to win the Grand Prize. One Finalist will be selected from the total eligible entries within each Entry Period (as set forth above).

Each drawing shall take place on or about at 1:00 p.m. Eastern Daylight Time on the Monday following the end of that Entry Period. The drawings shall be supervised by Thirty Second Street Media pursuant to an agreement between LifeStream and Thirty Second Street Media, at Thirty Second Street Media’s office at 13256 Ft Caroline Road, Suite 1, Jacksonville, Florida 32225, which such location may be changed at any time and from time to time without notice at LifeStream’s discretion. The last Finalist shall be chosen from all the entries received at Toyota of San Bernardino, 650 Auto Center Drive W, San Bernardino, CA 92408, on Saturday, August 31, 2024 from 10:00 am -2:00 pm California time, which such final drawing shall be done by an employee of Toyota of San Bernardino at or round 2:30 pm California time at the dealership.

Any entry received during any previous Entry Period above shall be automatically removed and disqualified from the next or any future Entry Period(s); however, a person is eligible to win more than one Finalist Prize if they submit an eligible entry in any such future Entry Periods. All eligible entries shall be placed in a non-viewable container and an employee of Thirty Second Street Media, chosen by Thirty Second Street Media, will then randomly pick each Finalist from the collection of eligible entries therein, with the exception of the last drawing which shall be done by an employee of Toyota of San Bernardino at or round 2:30 pm California

time at the dealership. The Finalist drawings will be conducted with a video call with LifeStream, such that an employee of LifeStream, chosen by LifeStream, may serve as a witness to the drawing. The final drawing at Toyota of San Bernardino shall be done in the presence of an employee of LifeStream, chosen by LifeStream, who will serve as a witness. No eligible person need be present at any drawing for the Finalists, **but each Finalist must be present** at Toyota of San Bernardino in order to be eligible to win the Grand Prize.

After each drawing, LifeStream will use its best efforts to contact each Finalist so chosen by telephone for two business days following the drawing. If contact cannot be made, the Finalist will be deemed ineligible and an alternate name will then be randomly drawn from among the remaining entries from that applicable Entry Period, on the third business day using the same procedures set forth above.

SELECTION OF GRAND PRIZE WINNER: The 13 weekly Finalists will be invited to a special event to be held at 3:00 P.M. on August 31, 2024 at Toyota of San Bernardino, 650 Auto Center Drive W, San Bernardino, CA 92408. The 14th Finalist will be chosen from among those submitting entries in person at Toyota of San Bernardino on August 31, 2024 as set forth above. Each Finalist will be presented with their Finalist Prize (the \$1,000 Carnival Cruise Lines gift card) at that time. Each Finalist will then draw a numbered key out of non-viewable container, which container shall contain 14 keys, each Key being numbered 1-14. The order of the drawing of the keys shall be predetermined in accordance with the order of the selection of the Finalists, with the first such Finalist so determined being the first Finalist drawing a key, the second Finalist determined being the second to pick a key and so forth until all keys have been picked. A Finalist may pick a key with a number which does not match the Finalist's picking order. Starting with the Finalist who drew the Key numbered 1, each Finalist will be directed to the 2024 Toyota BZ4X displayed at the Grand Prize drawing. One of the keys drawn by a Finalist will "unlock" the 2024 Toyota BZ4X. The Finalist whose key "unlocks" the 2024 Toyota BZ4X will be deemed the Grand Prize winner and, upon compliance with all of the rules and regulations herein, will receive the 2024 Toyota BZ4X. 2024 Toyota BZ4X. As stated hereinabove, if the winner does not wish to accept the 2024 Toyota BZ4X vehicle, they will have the option to instead accept a one-time payment \$15,000 from Toyota of San Bernardino.

Finalists must be present at the drawing in order to be eligible to be awarded the Grand Prize. All entries are non-transferable. If a Finalist is not present, then 1 key (for each Finalist not present) will be removed from the container. The Grand Prize drawing will be held under the supervision of LifeStream employees, whose decisions are final and binding. Each Finalist is solely responsible for any costs associated with traveling to the Grand Prize drawing site.

Each Finalist will be required to provide proof of a driver's license valid in the United States and proof of insurance. ODD OF WINNING: THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED ACCORDING TO THE ELIGIBILITY REQUIREMENTS AND UPON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE APPLICABLE ENTRY PERIOD AND THE NUMBER OF FINALISTS SHOWING UP IN PERSON AT THE DRAWING FOR THE GRAND PRIZE.
